### President's Letter -

#### **RIMA-I Code Committee Formed**

RIMA-I has formed a new "Code & Legislative Committee." As the next step in RIMA-I's growth, this committee will be involved in code changes that positively affect our industry and proactively propose positive code changes. Within this committee is also RIMA-I's Government Affairs team. The Code & Legislative Committee has been in the works for quite a while and was formally formed at our Atlanta board meeting. Although code and government affairs have previously been underutilized portions of our core disciplines, they have grown in importance to RIMA-I members who wish to have a consolidated voice not only with codes but in Washington, D.C., as well.

#### **Radiant Barriers Qualify for ARA Tax Credit**

David Yarbrough and I traveled to Washington, D.C., to attend a meeting with the Internal Revenue Service's Chief Council. During this meeting, it was determined that radiant barriers qualify for the American Recovery

Act energy tax credit. RIMA has contracted with R&D Services to calculate the appropriate values as backup for reports proving that radiant barriers meet the 2009 IECC prescriptive code. We anticipate this work to be completed very soon, allowing RIMA-I members to disseminate certificates of compliance to their customers with an assurance that RIMA-I maintains the appropriate data to support their claims. This is a "members-only" program. A couple of cautionary points to not forget:

- 1. A certificate issued by a manufacturer will be accepted as long as a negative ruling is not issued. Fraudulent performance claims, however, can lead to legal action from either the IRS or FTC.
- 2. An IRS examiner can review an individual return for accuracy.

#### U.S. Housing Starts Declined

U.S. housing starts, possibly held back by bad weather, declined 4.0% in December. Total 2009 starts of 553,800 were down 351,700 from 2008, a decline of 39%. The positive news was the 8.3% increase in single-family permits.

#### **Home Star Proposal Detailed**

We have fielded several questions about a "cash for caulkers" program, and it appears there is some level of interest in this effort. Below is a summary of what we have discovered thus far; however, there are more details to be unearthed. Keep in mind that the proposed "Home Star" program details change regularly, and no legislation has been introduced yet.

The Home Star proposal creates strong incentives for homeowners to retrofit existing residential buildings in order to improve energy efficiency and create jobs quickly. It is proposed to provide two types of rebate incentives to U.S. consumers:

- 1. A Silver Star performance path rewards the purchase and proper installation of specific energy savings, including:
  - a. Full-house air-sealing
  - b. Duct seal or replacement
  - c. Wall insulation
  - d. Window/door/skylight replacement

- e. Furnace installation
- f. Air conditioner or heat pump
- g. Water heater
- h. Super-efficient refrigerator or clothes washer
- 2. A Gold Star performance path would offer an incentive to households that choose to conduct a comprehensive energy audit and then implement a variety of energy-saving measures that together result in a total reduction in home energy use (and energy bills) of 20% or more. Consumers receive \$3,000 for modeled savings of 20%, plus an additional \$1,500 incentive for each additional 5% reduction in energy savings, with incentives not to exceed 50% of project costs or \$12,000, whichever is less. Installers would have to receive additional certification (probably from DOE) to perform these improvements.

The incentives in Home Star's prescriptive path are based on the number of measures installed in the home. Homeowners receive anywhere from \$125 to \$1,500 for each of 11 measures installed in the home (rebate amount varies depending on each measure) by a qualified contractor, with a benefit not exceeding \$3,000 or 50% of total project costs, whichever is less.

Currently, there is not a "DIY" component to the program. A consumer would have to use a qualified contractor for installation to receive any rebate. It also appears that DOE would be the Home Star police, answering directly to Congress.

#### **Looking Forward**

### Help Discover 'Who Done It' at The Lemp Mansion

Members coming in for Saturday's meetings will be ending the day at special group dinner outing at The Lemp Mansion where you will help solve the mystery of "Murder in Mayberry".

The Lemp Mansion was the home of John Adam Lemp who arrived in St. Louis from Eschwege, Germany in 1838. He originally sought his fortune as a grocer. His store was unique for its ability to supply an item sold by none of his competitors - lager beer. Lemp had learned the art of brewing the effervescent beverage under the tutelage of his father in Eschwege, and the natural cave system under St. Louis provided the perfect temperature for aging beer. In1840 he abandoned the grocery business to build a modest brewery at 112 S. Second Street. The brewery enjoyed marvelous success and John Adam Lemp

died a millionaire. William J. Lemp succeeded his father as the head of the brewery and he soon built it into an industrial giant. In 1864 a new plant was erected at Cherokee Street and Carondolet Avenue. The size of the brewery grew with the demand for its product and it soon covered five city blocks. In 1870 Lemp was by far the largest brewery in St. Louis and the Lemp family symbolized the city's wealth and power. In 1892 the brewery was incorporated as the William J. Lemp Brewing Co. In 1897 two of the brewing industry's titans toasted each other when William Lemp's daughter, Hilda, married Gustav Pabst of the noted Milwaukee brewing family.

The demise of the Lemp empire is one of the great mercantile mysteries of St. Louis. The first major fissure in the Lemp dynasty occurred when Frederick Lemp, William's favorite son and the heir apparent to the brewery presidency, died under mysterious circumstances in 1901. Three years later, William J. Lemp shot himself in the head in a bedroom at the family mansion, apparently still grieving the loss of his beloved Frederick. William J. Lemp, Jr. succeeded his father as president. Tragedy continued to stalk the Lemps with startling ardor. The brewery's fortunes continued to decline until Prohibition (1919) closed the plant permanently. William Jr.'s sister Elsa, who was considered the wealthiest heiress in St. Louis, committed suicide in 1920. On June 28, 1922, the magnificent Lemp brewery, which had once been valued at \$7 million and covered ten city blocks, was sold at auction to International Shoe Co. for \$588,500. Although most of the company's assets were liquidated, the Lemps continued to have an almost morbid attachment for the family mansion. After presiding over the sale of the brewery, William J. Lemp, Jr. shot himself in the same building where his father died eighteen years earlier. His son, William Lemp III, was forty-two when he died of a heart attack in 1943. William Jr.'s brother, Charles, continued to reside at the house after his brother's suicide. An extremely bitter man, Charles led a reclusive existence until he too died of a self-inflicted gunshot wound. The body was discovered by his brother, Edwin. In 1970, Edwin Lemp died of natural causes at the age of ninety.
