RIMA-I is pleased to have Vicki Lovell of InterCode, Inc., as our first guest speaker on Saturday, October 24<sup>th</sup> at 11 a.m. Vickie is the President of InterCode Inc., an independent consulting firm located in Delray Beach, Florida. InterCode provides representation and advocacy to companies and trade associations whose materials or products are affected by building codes and standards. InterCode develops customized code development campaigns to create new requirements, or defend existing requirements in the building, fire, energy, and mechanical codes. InterCode also provides technical writing services, strategic planning, product and market forecasting, and product commercialization. Ms. Lovell has been representing clients in the model building code development hearings for over 25 years and has been working with RIMA International for the past two years. Vicki and her team have been invaluable to the code work Wes Hall and his Code & Legislative Committee have been diligently pursuing, and we are very pleased to have Vicki here to discuss where things are and what we can expect ahead. #### Joshua New from ORNL Talks Software

Dr. Joshua New is a computer scientist joining Oak Ridge National Laboratory (ORNL) in 2009. He received his Ph.D. in Computer Science at the University of Tennessee in 2009, his M.S. in Computer Systems and Software Design and his B.S. with a double major in Computer Science and Mathematics with a Physics minor from Jacksonville State University. Dr. New currently serves at ORNL's Building Technology Research Integration Center (BTRIC) as subprogram manager for software tools and models. He has over 70 peer-reviewed publications and has lead more than 40 competitively-awarded projects involving websites, web services, databases, simulation development, visual analytics, supercomputing using the world's #1 fastest supercomputer and artificial intelligence for big data mining. He is also an active member of IEEE and ASHRAE.

The Department of Energy's Roof Savings Calculator (RSC) was developed to function as an industry-

consensus standard for energy savings from modern roof and attic technologies for residential and commercial buildings. It uses DOE-2.1E for fast, using whole-building energy simulations and integrates AtticSim, an ASTM standard, for advanced modeling of the roof assembly. RSC can simulate radiant barriers, cool/reflective roofing, multiple roof/attic configurations, and slopes, above sheathing ventilation, low-emittance surfaces, duct locations, leakage rates, roof substrate types, and insulation levels. An annual simulation of hour-by-hour performance is calculated based on building properties and weather for the selected location. Annual energy savings are reported based on heating and cooling load reduction. This talk will present the context, capabilities, and validation efforts involving comparison to other simulation tools, analysis of modeling capabilities to expected behavior, and empirical validation with measured data. We appreciate Joshua taking the time to join us and look forward to his presentation at the Membership Meeting on Saturday.

## OTHER THINGS YOU SHOULD KNOW . . .

#### **RIMA-I** Committees Are Hard at Work

Since RIMA-I only meets face to face twice a year, the committees meet via conference call quarterly to keep all the association efforts continually moving forward. Here are a few brief updates on some of the recent committee tasks:

**International Committee** – The hotel has been contracted for the 2016 event and speakers and topics are being identified for the program. Crystal Gauvin of RISI has been confirmed as our keynote with several in the works. If you have a topic or speaker suggestion you'd like to see at this event, contact the RIMA-I office now!

**Verification Committee** – The committee is working to enhance the Verification Program to include UV exposure of non-metallic materials and thermal performance as part of the program.

**Technical Committee** – Several projects are in committee at this time including a review of the FAQ sheet for the RIMA-I website, technical bulletins on air films and air spaces, updates with the Corrosion Testing Task Group, ASTM C16 activity, Energy Star, ASHRAE, High Performance Building Council and more.

**Code & Legislative Committee** – Chairman Wes Hall has and continues to work diligently to address current code issues and prepare for the 2016 code effort. Working with the committee, InterCode and others, there are several code issues on the table.

**Strategic Alliance Committee** –This committee continues to work to bring uniformity in the software energy rating programs utilized to better and more accurately incorporate radiant barriers into a building. The committee is bringing in guest speaker Joshua New to discuss one such program and the work being done at ORNL.

**PR/Marketing/Membership** – The committee is discussing the idea of a new award/recognition program. They are also working with the Code Chair Wes Hall to develop more user-friendly updates on how the code issues being addressed can impact a member's business. Ongoing efforts include responding to Ask the Expert questions received, developing press releases on timely issues and sharing them not only in e-mail blasts but also on Facebook and LinkedIn. Opportunities to submit education articles are also on the radar as well as opportunities and ways to better serve our current membership as well as entice new members.

This is just a small sampling of the work each committee is doing. The Board of Directors and Past Presidents Advisory Council (PPAC) will also meet when we gather in Tampa. Our newest task group – the **Advanced Building Code Coalition** – will also meeting to discuss the upcoming launch of this new code effort.
